**Bylaw No. 12/2018**

**A Bylaw of the City of Yorkton in the Province of Saskatchewan  
to provide for the Exemption or Abatement of Taxation for  
Certain Properties within the City of Yorkton**

**WHEREAS**, the Council of the City of Yorkton may by bylaw, pursuant to section 262 (3) of *The Cities Act* exempt any property from taxation.

**NOW THEREFORE**, the Council of the City of Yorkton in Council assembled enacts that the following property taxes be exempt or abated to the extent as set out below:

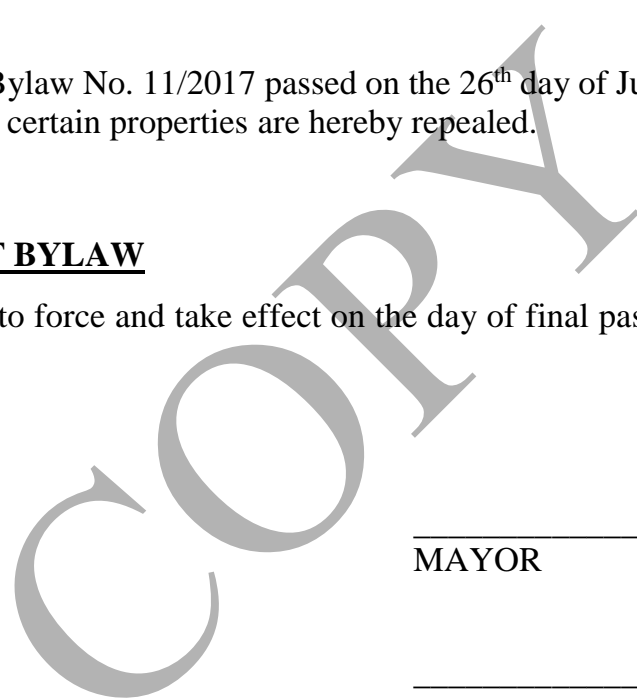
