BYLAW NO. 33/86

**A BYLAW OF THE CITY OF YORKTON TO PROVIDE FOR THE CLOSING OF LANES,
AS SUCH LANES ARE SHOWN IN A PLAN OF RECORD IN THE LAND TITLES
OFFICE FOR THE YORKTON LAND REGISTRATION DISTRICT AS PLAN NO. 20767**

WHEREAS it is deemed expedient and advisable to close certain lanes, as such lanes are shown in a Plan of Record in the Land Titles Office for the Yorkton Land Registration District as No. 20767; and

WHEREAS as provided in Section 156 of Chapter U-11 of the Revised Statutes of Saskatchewan 1984, being The Urban Municipality Act, the registered and assessed owners of land abutting on the said lanes have been notified by registered mail, and the required notices have been published in The Yorkton Enterprise under dates of May 15th, 1974 and May 22nd, 1974, and no petitions objecting to the closing of said lanes have been received; and

WHEREAS the Minister of the Department of Highways and Transportation for the Province of Saskatchewan has given his consent to the closing of the said lanes.

NOW THEREFORE the Council of the City of Yorkton in Council assembled enacts as follows:

Firstly: All that portion of the north south lane in Block Six (6), lying to the South of the production easterly of the north limit of Lot Eight (8) .

Secondly: All of the east west lane lying south of and adjacent to Lot Four (4) in Block Six (6) as the said lanes, block and lots are shown on a Plan of Record in the Land Titles Office for the Yorkton Land Registration District as No. 20767.

Introduced and read a first time this 15th day of December, A.D., 1986.

Read a second time this 15th day of December A.D., 1986.

Read a third time, after unanimous agreement had been reached to have a third reading, this 15th day of December A.D., 1986, and then passed unanimously this 15th day of December A.D. 1986 and registered in the Bylaw Register of the City of Yorkton.
