

Your City of Yorkton Utility Bill

- Your utility account number and service address.
- The date range for the applicable charges. Utility billing cycles are completed once every two months.
- Your mailing address. Please inform our office if any updates to your address are required.
- Record of last payment made on your account
- Billing code G02 is the fee for residential refuse collection services and applicable landfill fees.
- Billing code B02 is the minimum charge for all active utility accounts.
- Billing code E02 is the residential recycling service fee for the curbside collection of recyclable materials, handling and processing of materials. This fee also includes the cost of services for residential drop off bins located at several locations in the city.
- Billing code W02 is the calculated rate for both water and sewer consumption for the meter reading listed and charged at the rate applicable
- Water consumption in cubic meters for the dates shown.
- Number of dwelling units for which this invoice has been charged. A single family home would be one unit, multi family dwellings would be two or more.
- Current levy represents the total of the transactions for the billing period stated.
- Amount due includes the amount calculated for the billing period stated as well as any unpaid balances carried forward from previous billing periods.
- For customers with an existing pre-authorized payment option on their account, the applicable payment withdrawal date is shown here.
- Important messages regarding your account that may include future changes or information on services.
