

# 5 and 10 year CPI Breakdown


We've managed to consistently beat CPI with our operating tax increase, with exceptions when funding was cut by higher orders of government or when additional costs (RCMP contract) were imposed on us.

Without those spikes, our ten year average would be 1.54% for an operating increase.



### DALEBROOKE DRIVE WATER MAIN REPLACEMENT PROGRAM

---



The total project cost is **\$2.98 million**.

The City of Yorkton is committed to renewing aging infrastructure with a strategic and cost-effective approach.

In 2025, Dalebrooke Drive will undergo a full infrastructure renewal project, focusing on essential upgrades to water, sewer, stormwater, and surface infrastructure.



# 2025 CONSTRUCTION CURRENT CAPITAL PROJECTS

## SMITH STREET CULVERT

Needed to regulate water levels at Deer Park, Ecological Preserve and JC Beach



## PARK STREET RESERVOIR PUMPING STATION

Additional potable water storage to meet additional demands from the city.  
New pumping station to allow the refurbished Park Street Reservoir to be used as part of the water distribution system.






The existing 2,277 sq ft terminal building is a holdover from the construction of the original war-time airport and is well past its useful life. The new building is proposed to be 2,552 sq ft in size, and provides space for a pilot lounge, reception desk, six leasable office spaces, runway electrical systems and building-related mechanical, public washrooms and a 490 sq ft attached garage, which will store the runway inspection vehicle and also fire suppression foam.

# YORKTON REGIONAL AIRPORT (YQV)

YQV plays a critical role in regional business retention and attraction as well as air ambulance provision.

The City is currently seeking a sponsor for Naming Rights for the airport.

The airport is home to a number of successful businesses that provide charter flights, aerial crop spraying, aircraft maintenance and repair, flight training, search and rescue, and FBO services.

Recent improvements:

- Crack sealing on pavement
- Friction index equipment
- Pavement repairs to the runway

Future considerations:

- Repainting markings and numbers on runways, taxiways and aprons
- New terminal building

# 2025 CONSTRUCTION

## UPCOMING CAPITAL PROJECTS

### HERITAGE HEIGHTS TENNIS COURT & PICKLEBALL EXPANSION PROJECT

**Total project budget is \$320,000**

Originally approved during the 2023/2024 capital budget process with a budget of \$220,000.

Scope of the project includes:

- The expansion of the existing court area to accommodate additional pickleball courts, resulting in two multi-use tennis/pickleball courts, and three dedicated pickleball courts.
- Complete re-surfacing of the entire court area with Sport Court surfacing.
- Installation of new anchors and nets for the expanded pickleball courts.
- Additional lighting for the expanded area installed on existing poles.
- Fencing and wind slats to enclose the court area.

An additional \$100,000 was allocated to the project in the 2025 capital budget, with Pickleball Yorkton contributing \$50,000 over 5 years towards the project.


### KINSMEN ARENA ICE SYSTEM UPGRADES

---



### PROJECT BUDGET: \$4.5 MILLION

- Installation of new rink systems, including the concrete arena floor (complete with new refrigeration piping), new rink boards, arena glass, player benches, spectator seating, and other arena amenities.
- Installation of dehumidification system.
- Upgrades to the mechanical and ice plant areas.
- Planned completion at the end of August, in time for skating & hockey to resume for the upcoming season.



# 2024 – 2025 CONSTRUCTION

## UPCOMING CAPITAL PROJECTS

### ACCESS COMMUNICATIONS WATER PARK

The City is investing \$1.4 million dollars into Access Communications Water Park this year, in conjunction with regularly scheduled shutdown maintenance.

This project will see replacement of the ozone water treatment system with new ultra-violet light treatment, as well as installation of new filtration systems for the entire water park.

Due to rising vehicle costs and the immediate availability of a transit van locally, the purchase was moved up and was completed in 2024.







# VACANT BUILDING TAX ABATEMENT

## INCENTIVE PROGRAM

This program provides incentives for vacant buildings or vacant portions of buildings that are occupied by new locally-owned businesses.

# VACANT BUILDING TAX ABATEMENT PROGRAM



Tax abatements will be applied to both new and existing assessment. Where an application is for a vacant portion of a building, the abatement will be applied proportionately to the new and existing assessment of the vacant portion.

Abatements will be implemented at the following rates:

- First year: 100%
- Second year: 75%
- Third year: 50%
- Fourth year: Return to full taxes


# BUSINESS LICENCE STATISTICS

# UNDERSTANDING DEVELOPMENT PERMITS


## INFORMAL DEVELOPMENT PERMITS (DPS)

Ensure zoning requirements are met for existing buildings/units that don't need alterations. For example a retail or service business transitioning into a similar space. Typically, there is no charge for informal DPS.

## FORMAL DEVELOPMENT PERMITS

Essential for new constructions or significant changes in building use, for example a retail store transitioning into a restaurant. Depending on the scope of the project, these might include:

- Building setbacks
- On-site parking solutions
- Hard surfacing requirements
- Comprehensive stormwater management
- Aesthetic landscaping
- Updated service connections



Since then, the building permits have been steady, with an increase in 2024.


Number of Building Permits Issued

Our city's strong relationship with these businesses has motivated them to promote Yorkton to other businesses considering future investment.




# BIDDINGO

The City of Yorkton has moved to a full electronic bidding portal as of April 4, 2022, called Biddingo.

With this partnership, vendors can now eliminate the necessity of searching for open bids with the City of Yorkton. Once a business completes the online vendor registration, they will be notified when a Tender becomes available that pertains to their business.

Vendors can register their business for free at any time!

# ADDRESSING MENTAL HEALTH & ADDICTIONS





# VOYENT ALERT

Voyent Alert! is a multi-purpose communication service used to send alerts to residents, businesses, and visitors during critical events like extreme weather, fires or floods, as well as for relevant day-to-day communications such as snow removal advisories, construction, road closures and water advisories.

The free notification system allows residents to create and track multiple locations such as “kid’s school” or “work”. Any event or communication related to your tracked locations will be forwarded to you along your preferred communication channel.


