Bylaw No. 8/2019

A Bylaw of the City of Yorkton in the Province of Saskatchewan to provide for the permanent closure of a portion of street right-of-way adjacent to 230 Broadway Street East.

WHEREAS, pursuant to Sections 8 (1)(g) and 13 of *The Cities Act*, the Council of the City of Yorkton in the Province of Saskatchewan in Council assembled hereby enacts that the following street be permanently closed:

1. As shown on Schedule 'A' attached hereto, all that portion of ST/L 1, Plan 86Y11910 Ext. 3 more particularly described as follows: commencing at a point on the Northerly production of the West Boundary of Block B, Plan 86Y11910, 10.55m Northeasterly of the Northwest corner of the said Block B; thence Southwesterly to the Northwest corner of said Block B; thence easterly along the north boundary of said Block B to the Northeast corner thereof; then Northerly on the production of the Eastern Boundary of Block B, Plan 86Y11910, 10.289m; thence Westerly to the point of commencement..

All those named Streets, Lanes, Blocks, and Plans being in the City of Yorkton, Province of Saskatchewan, Dominion of Canada; and

2. That Bylaw No. 3/2018 be repealed in its entirety.

This bylaw shall come into force and take effect on the date of final passing thereof.
